## Minutes of the 4th State Level NCORD Meeting

4<sup>th</sup> State Level NCORD meeting was held under the Chairmanship of Ch ef Secretary, Haryana on 6<sup>th</sup> April, 2023 and was attended by the Administrative Secretaries/Heads of Department/representatives of Stakeholder Departments. The Depu ty Commissioners/Superintendents of Police joined the meeting through video conferencing. The list of participants has been attached as Annexure-A. The action taken report on the decisions taken during the 3<sup>rd</sup> NCORD meeting was reviewed. The detailed deliberations 12d to the following conclusions:

 It was noted that meetings are being held by most of the Deputy Commissioners regularly every month. However, minutes need to be uploaded on the NCORD Por al regularly.

## (Action: All DCs and all District SPs)

The signed minutes of the meeting shall include a statement on the attachment/forfeiture of assets in the District under Chapter-VA of NDPS Act, 1985

#### (Action: All DCs and all District SFs)

HSNCB shall submit a proposal through DGP, Haryana for hiring of Financial, Legal
and IT Consultants under Haryana Police Act, 2007 toprovide hand-holding for
development, monitoring and pairvi of cases for forfeiture of assets by the
Competent Authority.

#### (Action: DGP/Haryana and IGP/HSNCB)

4. Systematic inspection of De-addiction Centres being run in the State shall be conducted by the SDMs and other district officials on monthly basis on the parameters prescribed by the Health Department and the Social Welfare Department. The report, duly signed by concerned DC and SP, shall be submitted as per prescribed format.

# (Action: All DCs, SPs, DG/SJ&E & IGP/HSNCB)

5. ACS Health & MER stated that the tasking of ASHA Workers for survey and identification as well as interview of drug addicts and their family members might not be feasible as the ASHA Workers are performing several other duties. Further that a plan/scheme shall be formulated for engaging a Survey Team in consultation with Director General, Social Justiceand Empowerment and ACS, Health under any of the existing schemes being run for de-addiction.

(Action: ACS/Health, DG/SJ&E, IGP/HSNC3)

6. A meeting shall be convened by ACS/Health under her Chairmanship of the representatives of Chemist Associations and other stakeholders to discuss the issues related to implementation of SAATHI Application for monitoring of stock and lale of prescription drugs. IGP/HSNCB shall attend the meeting.

## (Action: ACS/Health, Commissioner/FDA, IGP/HSNCB)

7. The Health Department shall undertake steps to finalize the guidelines for reporting of drug overdose deaths and the protocol for conducting postmortem examinationin such cases. A draft has already been submitted in this regard by HSNCB to the Health Department.

#### (Action: ACS/Health, DGP/Haryana and IGP/HSNCB)

 Steps would be taken to constitute the Advisory Board under Section-9 of PIT NDPS Act, 1988.

(Action: ACS/Fome)

 Steps would be taken to expedite grant of approval for hiring of contrictual manpower for FSL through HKRN for expeditious examination of exhibits in NDPS Act cases.

## (Action: ACS/Home and Director/FSL)

 The trial of cases involving seizure of commercial quantities of drugs should be closely monitored by the District Attorney.

# (Action: All DMs, SPs, District Attorney, Director Prosection)

- 11. The proposal of Police Department for hiring of Legal Advisers at Police Station level on contract through HALSA shall be examined for early decision by the Government.
  - (Action: ACS/Home)
- 12. The feasibility of amendment to NDPS Act for plugging the loophole created by arbitrary fixing of limits for commercial quantities of drugs shall be examined by the Law Department in discussion with the Police Department.

# (Action: ACS/Home, IGP/HSNCB)

13. The Social Justice and Empowerment Department shall evolve a system for periodic rating of De-addiction Centres based on objective assessment with the active involvement of NGOs/Stakeholders.

(Action: DG/SJ&E)

14. Nehru YuvaKendras to be actively engaged in creation of awareness against drugs amongst the youth.

(Action: ACS/Sports)

15. HSNCB to be formally designated as NCORD Secretariat.

(Action: ACS/Home)

16. The training calendar for training of IOs at HPA, Madhuban to be fixed in discussion with NCB, Chandigarh which shall provide resource persons for the same.

(Action: Director/HPA, PTC Sunaria, NCB-Chandigarh and IGP/HSNCB)

17. DGPrisons informed that Mr. Jagjeet Singh, IGPrisons has already been notified as the Nodal Officer of Prison Department.

DGPrisons also informed that 15 De-addiction Centres function in 15 Prisons (out of 20 Prisons) in Haryana. He also promised to share the manpower structure as well as the availability of Counselors and their eligibility etc. as per the Social Justice and Empowerment Ministry guidelines to the officers concerned for their information and use.

(Action: DG/Prisons)

18. The Excise Department shall consider the proposal of NCB for being assigned credentials for accessing e-way bill Portal.

(Action: ACS/E&T, IGP/HSNCB, NCB-Chandigarh)

19. All Stakeholder Departments and District Administrations shall plan awareness activities for 26<sup>th</sup> June, 2023.

(Action: By all Stakeholder Departments, all DCs, all SPs, IGP/HSI ICB)

20. A proposal for seeking central assistance for strengthening of De-addiction and Rehabilitation Centres shall be worked out in consultation with the Social Justice and Empowerment Department. The model of assistance being provided for Deaddiction Centres in prisons may be consulted and replicated.
