3. **The Institute** and the Industry shall explore the possibilities of mutual support in their learning, hiring and research requirements based on mutual convenience.
4. Industry will provide the expert from their organisation for expert lecture on the demand of the Institute for which a remuneration will be paid by first party to the expert sent by second party as per Govt. Norms
5. The second party will prefer for placement to the students of first party in place of other institute if the second party found suitable as per their requirement and up to mark area in a year.
6. **Confidentiality:** Each party shall maintain complete confidentiality of any information of the other, disclosed during the term of this M.O.U.
7. In no event shall either party be liable for any indirect, incidental, special, consequential damages, including, but not limited to, loss of profits, revenue, data or use, incurred by the other party in connection with, arising out of or under this M.O.U. save for any such loss suffered resulting from any wilful and grossly negligent act or omission of either of the parties.
8. Neither this M.O.U., nor any activities described herein, shall be construed as creating a partnership, joint venture, agency or other such relationship. Both parties agree that this M.O.U. represents a nonexclusive relationship between the parties and nothing contained herein shall preclude either party from participating/initiating similar relationship with third parties.
9. This M.O.U. may not amend without the prior written consent of both the parties.
10. **This M.O.U. will be effective for one year from 21.08.2023. This Agreement can be renewed based on mutual convenience.**
11. **Termination:** Either party can cancel or terminate this Agreement unilaterally (and without reason), by giving an advance written notice of one month to the other.
12. **Indemnity:** Each of the parties shall defend, indemnify and hold the other party harmless from and against any claim, liability, loss, costs or expense (including reasonable Attorney's fees) arising out of or resulting from the material breach of the provisions herein
